- Monthly Payment** Twelve payments of \$916.66 are each due before the first day of each month from July to June.*

* All payments must be made by means of an approved payment plan (credit card, automatic bank draft, pre-dated checks, etc.) which I will be responsible to set up prior to July 1, 2024.

The undersigned agrees to release and hold harmless, the school, its agents and employees from all claims, damages or other liabilities for injuries to my child which are not the result of gross negligence by this school, its agents or employees. The undersigned also agrees to indemnify the school for damages by my child(ren). I hereby give permission for my child(ren) to attend all school-sponsored trips and activities. Furthermore, I agree to the policy of the school that student grades and transcripts will not be released unless an account has been paid in full. I understand that the school shall have the right to pursue legal action for collection of school tuition and fees and that parents will be responsible for all costs of collection, including court expenses and reasonable attorney's fees.

Enrollment, as specified within this Enrollment Contract, may be canceled without penalty (except forfeit of the Registration Deposit) upon written notice received before August 15, 2024. If enrollment is canceled after August 15, 2024, parents or guardians financially responsible for the student(s) are obligated to pay the full annual charges.

This contract shall be interpreted in accordance with the laws of the Commonwealth of Virginia and cannot be modified without the written consent of all parties.
